Introduction:

The workshop on Juristions of Trade Secrets was held on December 28,2019 at JKKMMRF's Annai Sampooorani Ammal College of Pharmacy. Format:

The workshop was structured as a combination of lectures, group discussions, and hands-on exercises. 


