Introduction:

The seminar on Enforcement of Intellectual Property Rights was held on 16th February, 2024 at JKKMMRF's Annai JKK Sampooraniammal College of Pharmacy. They also learned about the different sections involved in the Indian Patent Act.

Conclusion:



Recommendations:


